SC: Minority status to be decided state-wise

New Delhi, (UNI) The Supreme Court on Monday reiterated that religious and linguistic minority status has to be decided state-wise and made it clear that it is the law of the land since 1957. A two-judge bench headed by Justice U U Lalit and also comprising Justice S Ravindra Bhat was hearing a plea filed by Bharatiya Janata Party (BJP) leader and lawyer Ashwini Kumar Upadhyay seeking to declare Hindu as minority in states where they are outnumbered by other communities.

The petition challenged a 1993 notification declaring Muslims, Sikhs, Buddhists, Parsi and Jains as minorities at the national level. The Supreme Court on Monday listed for hearing for first week of September a petition filed

seeking identification of minorities at the district level instead of at the national level.

The Bench told the petitioner: "Theoretically, you may be right. Hindus may be in a minority in many states." The court has many a times said that minorities are to be identified at the state level. It will have to be done on a caseto-case basis. "You give us examples of Hindus being in minority," the Bench said. The counsel appearing for the petitioner told the Court that similar matters were pending before the Bench of Justice Sanjay Kaul.

The Bench observed that the prayer for identification of minorities at the district level is against the judgment of an 11-judge Bench of the Court and is not maintainable.

Odisha to introduce gender equity curriculum across govt schools

Bhubaneswar, (UNI) Odisha government on Monday signed an MoU with Breakthrough and the Abdul Latif Jameel Poverty Action Lab (J-PAL) South Asia to integrate a gender equity curriculum into the syllabus for students government across schools in the state. The MoU was signed in the presence of officials of Odisha for School and Mass Education Department, Sohini Bhattacharya, CEO, Breakthrough, Shobhini Mukerji, Executive Director, J-PAL South Asia, and several other officials from the department. The curriculum, designed by the NGO Breakthrough, uses interactive classroom discussions to encourage adolescent boys and girls to reflect on culturally em-



bedded gender norms, roles, and discriminatory practices to transform their gender attitudes, aspirations, and behaviours.

Through this partnership, the curriculum will be integrated into the Social Studies syllabus for adolescent boys and girls from Grades 6 to 10 in over 18,000 elementary and 5,000 secondary schools in Odisha by August 2022. School

and Mass Education Department, Principal Secretary Bishnupada Sethi said "The inclusion of gender dimension in the school curriculum is a very notable step for Odisha. Despite the gains and progress, India has made in gender equality, some issues continue to remain unaddressed even today. The curriculum was first evaluated by J-PAL South Asia

in 314 government schools in Haryana and was found to shift the gender attitudes and behaviours of both boys and girls and lead students to enact more gender-equitable behaviours. The curriculum has since been introduced in multiple states in India, including Punjab where it is currently reaching 600,000 students annually in government schools across the state.

In Odisha, Breakthrough will work with the Department of School and Mass Education to contextualize and integrate the curriculum into the syllabus, train teachers and key departmental personnel, and conduct gender sensitization workshops with teachers across 23,000 state-run schools.

Odisha logs 652 new covid cases, one death

Bhubaneswar, (UNI) Odisha reported 652 new covid positive cases including 132 in the age group of 0 to 18 years in the past 24 hours taking the total tally in the state to 13,19,527. Official sources said the total recovery rose to 13,04,527 after 704 covid patients undergoing treatment were cured from the virus in the past 24 hours. One covid death was reported during the health audit process pushing the total fatalities in the state to 9149. The active cases further declined to 5798 while the daily Test Positivity Rate (TPR) stood at 3.63 per cent. Health and Family Welfare department sources said out of 652 new cases,381 were recorded from the quarantine centres and 271 as local contact cases. Sundargarh registered the highest number of 137 cases followed by Khordha(70), Sambalpur(58), Bolangir (47), Bargarh (46) and Mayrubhanj (43). These six districts together contributed 61.5 per cent of the total new cases reported in the state in the past 24 hours.

Similarly, out of 5798 active cases, Sundargarh recorded a maximum of 1357 cases followed by Khordha(789), Sambalpur (432), Bargarh (412) and Mayurbhanj (337). These five districts alone accounted for 57.41 per cent of the total active cases in the state. Although the state's TPR stood at 3.63 per cent but five districts such as Sonepur, Kalaahndi, Sambalpur Sundargarh and Bargarh, all in Western Odisha, reported the TPR above 7.5 per cent. Sonepur registered the highest TPR of 22.8 per cent followed by Kalahandi (105 per cent) and Sambalpur (10.4 per cent) Sundargarh (10 per cent). On the other hand, Bolangir, Kandhamal, Boudh and Mayurbhanj registered TPR above 5 per cent.

Maintain decency dignity and decorum, Naidu's last message to MPs

New Delhi, (UNI) As the House bid an emotional farewell to him, Rajya Sabha Chairman M. Venkaiah Naidu in his last message on Monday urged MPs to maintain decency, dignity and decorum so the "image and respect of the House is maintained." He said that since people are watching the Parliamentary proceedings, he has to take the tough decision of naming some members otherwise he has no ill-will against anybody or any party. Speaking in the end during 'Farewell to Hon'ble Chairman', Naidu said, "In a parliamentary democracy... We being the upper house have a greater responsibility. The entire world is watching India. I only appeal to the members of Rajya Sabha to maintain decency, dignity and decorum. So that the image of the House, and the respect is maintained and people remain receptive to show us, to hear us, and follow our advice.'

"This is my advice to all



of you. As I told you, the students, the rural people, the ordinary people will be watching the parliamentary proceedings. That's why sometimes I have to intervene and sometimes I have to take not a very happy decision of naming some people. Otherwise there is no enjoyment in taking such extreme action. I have no ill-will against anybody or any party," Naidu added. Naidu said that people (members) always ask him not to pass the Bill in the din. But further solution is that do not create din, and do not pass the Bill in the the din, he said. "The respect is declining everywhere because the value system is declining. Keep that in mind. Try to do your bit while committing yourself to your ideological line. But see to it that that democratic principles set by our great people are followed," he said.

"We are not enemies, we are rivals. We must work hard to outshine others, like in a competition. But not to run down others. This is my last advice to you. My wish is that Parliament functions well. There are many members very good at speaking when the opportunity comes," he added. Naidu said that people want the House to discuss the debate and decide, means three 'D', they don't want the other 'D' means disrupt, he lightly said in his trademark style. Naidu also adviced to media to

structively. "In media also, they don't report of you speak constructively. If you speak obstructively, do something unusual, it is getting coverage. It's a weakness of the media and media should get out of it at the earliest without trying to give some reasons here and there," he said. The Chairman also recalled the time when the Prime Minister informed him that he was being chosen for Vice President. "The day when I decided to be the Vice President of India, with a heavy heart, I announced then and there, when the Prime Minister told me that I am being selected, I was in tears. I might not have given them (members) enough time that they wanted but each one of you have been given time, whether it is Zero Hour, Question Hour, Special Mention or debate and discussion on the Bills, he added. Naidu also expressed his affection for the mother tongue saying the use of mother tongue needs to be encouraged. "I am happy that the President, the Prime Minister, the Chief Justice.. all are speaking

about respecting mother tongue. Primacy should be given to mother tongue," he said. I am thankful to the Prime Minister who has given me love and affection, the Chairman concluded while

Rajya Sabha stands adjourned 4 days ahead of schedule

New Delhi, (UNI) The Rajya Sabha was adjourned sine die on Monday four days ahead of the schedule with the House taking up 'Farewell to the Chairman Venkaiah Naidu' and passing 'The Central Universities (Amendment) Bill, 2022' on the last day of Monsoon Session. The Monsoon Session was scheduled between July 18 to August 12. Chairman Venkaiah Naidu, who is set to retire on August 10, said the House had 16 sittings during which it conducted its Business for more than 35 Hours. "However, more than 47 Hours were lost due to interruptions, which is a sad reflection on the functioning of the Upper House of Parliament," Naidu said while concluding the Ses-



sion. He said that the Session was characterized by regular and continuous disruptions, which deprived Members of the opportunity to discuss matters of urgent public importance and seek the accountability of the Executive through ques-

"Out of the 235 Starred Questions admitted, only 61 could be answered orally and Question Hour could not be taken up on 7 days. Only 25 Matters could be raised by Members with the permission of the Chair and only 60 Special Mentions could

be made, during the entire Session," he said. The House discussed the issue of rising prices of essential items in the form of a Short Duration Discussion which lasted for more than 4 hours in which 33 MPs participated in the debate. "Only 4 Government Bills were considered and passed during the Session. 27 Private Members' Bills were also introduced and only 1 Private Member's Bill regarding 'Right to Health' could be partly discussed during the entire Session," Naidu said. No Private Members' Resolutions could be taken up, he added. Earlier, the government made clear its intentions to adjourn the Parliament ahead of schedule.

US climate bill clears Senate hurdle

Washington, (UNI) Democrats got emotional throwing fists into the air after the US Senate finally approved a key legislation of President Joe Biden's on the domestic front.

The bill that took 18months of wrangling will now be sent to the Democrats-controlled House where it could pass as soon as this week.

The Inflation Reduction Act includes \$369 billion for climate action - the largest investment in US history, is expected to reduce US carbon emissions by 40 per cent by 2030, the BBC reported.

With the US midterm polls just months away, the bill's passage into law would mark a major achievement for the White House's longstalled domestic economic agenda.

It would also raise corporate taxes and lower healthcare costs as part



of a package surpassing \$700billion, which the White House says will pay for itself.

Democrats negotiated among themselves for months to ensure the bill received the support of every one of the party's 50 senators, which it required - alongside Vice President Kamala Harris's tie-breaking vote - to pass the Senate.

The resulting compromise is a significantly scaled-down version of a far more expansive measure that many Democrats had hoped to approve last year. Some Republicans have said they will try to stall or block the progress of the bill, which also includes \$64 billion for healthcare.

It now needs to be approved by the House, where Democrats have a slightly larger majority and expect to pass it with ease, before it can be signed into law by Biden.

Raising his fist in the air, Democratic Senate majority leader Chuck Schumer said "after more than a year of hard work, the senate is making history". "To Americans who've lost faith that Congress can do big things, this bill is for you," he added.

Senator Brian Schatz, a Democrat from Hawaii, reportedly cried tears of joy as he left the chamber.

"Now I can look my kid in the eye and say we're really doing something about the climate," he said according to the New York Times.

Florida's Republican Senator Marco Rubio argued the bill was out of touch as it doesn't help lower prices for working people or keep criminals in jail, the BBC reported. ric cardiologist has carried out a Covid-related study that shows vaccine-associated myocarditis risk among adolescents.

Researchers from Australia's Monash University have completed a study of vaccine-associated myocarditis risk in adolescents, showing that risks are "mild" and outweighed by the longterm risks of Covid-19.

The study, published in the Medical Journal of Australia on Monday, followed the course of 33 adolescents, between the ages of 12 and 18, who presented to Monash Children's Hospital with typical symptoms of myocarditis following receiving a Covid-19 vaccine, reports Xinhua.

Monash Children's Hospital, the study was the largest of its kind for a single children's hospital. Varma is from the Government Medical College, Kozhikode.

China's military drills near Taiwan continue according to plan

Beijing, (UNI) The Chinese People's Liberation Army (PLA) continued on Sunday exercises off Taiwan in accordance with the army's plan, the PLA's Eastern Theater Command said.

"In accordance to the plan, the PLA's Eastern Theater Command on August 7 continued joint practical military exercises in the sea and airspace around the island of Taiwan," the command said in a statement on WeChat.

On Thursday, China launched large-scale military exercises in the eastern Taiwan Strait in response to US House Speaker Nancy Pelosi's visit to Taipei. The drills were expected to continue until 12 p.m. local time (04:00 GMT) on Sunday. The China Maritime Safety Administration (MSA) said on Saturday that the PLA would conduct military exercises with live fire in the southern part of the Yellow Sea on August 6-15.

Pelosi visited Taipei on August 2-3 while on an Asia tour despite warnings from China, which considers Taiwan part of its territory and opposes any direct official foreign contacts with the island. She was the first highestranking US official to visit Taiwan in 25 years. The visit triggered a new

round of tension in the Taiwan Strait. In addition to the launch of military exercises this week, Beijing imposed sanctions against two Taiwanese foundations for separatist activities, suspended the export of natural sand to the island and the import of citrus fruits, as well as some types of fish products from Taiwan. The Chinese Foreign Ministry said that Washington and Taipei were yet to face all the negative consequences of the visit, which Beijing had opposed for several months.

China increases duty free access to Bangladeshi products by another 1 pc Dhaka, (UNI) Chinese

foreign minister Wang Yi expressed gratitude to the Bangladesh government for reiterating its support to the "One China" policy. He explained China's position on the Taiwan issue during a meeting with Bangladesh foreign minister AK Abdul Momen.

Md Shahriar Alam, state minister for foreign affairs, told newspersons this after a meeting of the two foreign ministers at a hotel in the capital city on Sunday morning.

He also informed the media that the meeting between the foreign ministers continued for an hour. Later, they signed four instruments and MoUs. Those are – handing over certificate of 8th Bangladesh-China Friendship Bridge in Pirojpur, renewal of five-year MoU on assistance in disaster management, renewal of MoU on cultural cooperation for 2022-2027, MoU on Marine Science between Dhaka University and China's First Institute of Oceanography.

Wang Yi arrived in Bangladesh on two-day state visit on Saturday afternoon. On the second day of the visit on Sunday morning, foreign ministers of both the countries led respective delegations at a breakfast meeting at a city hotel. Later, he went to Gonobhaban to pay a courtesy call on prime minister Sheikh Hasina. Wang Yi will leave Dhaka after the courtesy call on.

Bangladesh's state minis-

ter for foreign affairs said China seeks collaboration in building a common future for all the countries initiative. The China foreign minister also mentioned that there are some countries that either misunderstand China or make mistake in explaining China's intention. We talked about that, Shahriar added.

Wang Yi is visiting Bangladesh at a time when tension is prevailing between China and the US over Taiwan issue. Chinese president Xi Jinping recently announced about forums like Global Security Initiative (GSI) and Global Development Initiative (GDI). China seeks Bangladesh by them in such initiatives.

Any attack on N-plant 'suicidal': UN chief

United Nations, (UNI) UN Secretary General Antonio Guterres on Monday said he hoped international inspectors will be allowed access to Ukraine's Zaporizhzhia nuclear power plant after both Ukraine and Russia accused each other of shelling the site, prompting grave warnings.

Zaporizhzhia, in southeast Ukraine, is Europe's largest nuclear power plant and was seized by the Russians in March but kept its Ukrainian employees.

"Any attack to a nuclear plant is a suicidal thing," Guterres said, as the watchdog called it "very

real risk of a nuclear disaster", the reported.Russian forces currently hold the plant and surrounding areas, close to Ukrainian-held territory. It consists of six pressurised water reactors and stores radioactive waste.

Over the weekend, Ukraine and Russia both accused each other of shelling the plant, prompting warnings of disaster from the International Atomic Energy Agency.

The power plant is in the city of Enerhodar, in the south-east of Ukraine along the left bank of the Dnipro River.

Bogota, (UNI) Colombian President Gustavo Petro has called for a fresh global strategy to combat illegal drugs trafficking.

Speaking at his inauguration on Sunday, the country's first ever leftwing leader declared the "war on drugs" a failure, a BBC report said.

Hundreds of thousands of people died in Colombia's

decades-long civil war, fuelled in part by the narcotics trade.

The 62-year-old former Bogota mayor and exrebel fighter was elected in June on a radical manifesto promising to fight inequality and ban new oil projects.

Petro told the crowd present that it is time for


a new global convention that "accepts the war on drugs has failed".

"It has left a million dead Latin Americans during 40 years," he said, "and it leaves 70,000 North Americans dead by overdose each year."

More than 50 years ago, US President Richard Nixon kick-started a glo-

bal anti-narcotics strategy that emphasised criminalisation and the use of police force, which became known as the "war on drugs".

Colombia's new president said the strategy has merely strengthened the power of mafia gangs and weakened Latin American states over decades.

Cash reward for info on Shrikant Tyagi

Noida, (UNI) After demolishing illegal structures erected by Shrikant Tyagi at a Noida society, the Gautam Buddha Nagar Commissionerate on Monday announced a cash reward of Rs 25,000 on the beleaguered self-proclaimed BJP leader even as searches were underway at multiple locations to arrest him.

The Media Cell of the Police Commissionerate said that a reward of Rs 25,000 has been announced on the arrest of accused Shrikant Tyagi in connection with The action came after the case lodged at Phase 2 police station.

Official sources said that raids were being carried out at multiple locations, including Lucknow, Meerut and Muzaffarnagar to arrest Tyagi. "His last location has been traced and the Special Task Force (STF) has been engaged in the operation," they said.

Earlier in the day, the Noida Administration brought in bulldozers and demolished illegal constructions by Shrikant Tyagi, who has been absconding after he was booked for misbehaving with a woman at a Noida Society.

Churchill's appeal

WOODSTOCK: Mr. Winston Churchill, Britain's wartime leader, said yesterday that he could not have believed that "on the morrow of the German and Japanese surrenders so short a period of time could bring Britain so low". He was addressing a crowd of 50,000 people in the grounds of his birthplace, Blenheim Palace, near here, on the eve of Parliament's two-day debate on the state of the nation and the British Government's expected proposals for tackling Britain's economic crisis. It was his first major political speech since last May when he had to retire temporarily from political activity because of an operation. Yesterday's crowd was attending a great Conservative garden

"Cabinet Ministers tell us every weekend how bad our position is and that the twelfth hour will strike before the end of the year," he said. "The main facts are obvious to every thinking man or woman. Under the capitalist system's free enterprise, we bred in Great Britain nearly 40,000,000 people, half of whose food came from beyond the seas but whose progress was constant and whose standard of living before the war was already the highest in Europe. Since then, two disasters have come upon us: The Second World War and the first Socialist Government with a majority. By supreme exertions, we surmounted the first disaster. The question which glares upon us today is: How shall we free ourselves from the second?"While Britain has "blithely cast away mighty India and Burma," the Socialist Government has "clung to tiny Little Palestine," he added. Democracy and Hindutva

India needs grassroots, representative politics, not identity politics

The foremost question in the minds of political observers on the 75th anniversary of India's Independence is about the future of its democracy. Is India on a perilous path of majoritarian rule? Is political Hinduism or Hindutva going to be the tool of authoritarianism in the days to come? Many political scientists have written off Indian democracy as some sort of an oxymoron and are busy coining terms like undeclared emergency, ethnic authoritarianism, electoral dictatorship or even outright fascist one-party rule. But a closer analysis of the Indian situation would belie such intellectual acrobatics of the ousted elite of a failed establishment.

Even the Hindi heartland would dump Hindutva if a credible alternative offers hope and change. In the North, J&K cannot be ruled by Hindutva simply because of the lack of a Hindu majority. In Punjab, despite over 40 per cent Hindu population, the BJP won just two seats out of 117 and a measly 6.6 per cent votes. The AAP's dazzling foray into Punjab was backed by its delivery, packaged in the Tricolour, in Delhi, where BJP's Hindutva had failed again. 'From Kashmir to Kanyakumari' is how generalisations are dished out for everything, from pickles to politics. Interestingly, the BJP's situation in Tamil Nadu is worse than it is in J&K: In 2021, it won just four seats despite partnering with the ruling party. Many in the AIADMK believe that their party was reduced to 66 seats only because of the BJP. Many in North India do not realise that Tamil Nadu is the repository of ancient Hindu temples and practices — so, staunch believers with religious markings on their forehead have voted in the DMK.But for Karnataka, there is not a single BJP government in South India. It drew a blank in the 2021 Kerala Assembly poll; the Vijayan government is surviving primarily because of the reasonable attitude of the Enforcement Directorate, which refuses to question the CM or his family in the gold smuggling case. The saffron party could not win a seat in the Andhra Pradesh Assembly election in 2019 and won just one in the Telangana Assembly poll in 2018, when Majlis-e-Ittehadul Muslimeen, the party of political Islam, won seven seats. In the West, the ugly saga of a mandate first being stolen from the single largest party and then stolen right back by the single largest party with a new Maratha satrap riding the Trojan horse has only proven that Indian democracy is alive and frolicking in all its filthy love for the lucre. In the East, Mamata Banerjee's Trinamool Congress won 213 seats out of 292 last year, making mincemeat of the BJP's Didi-o-Didi campaign. Even when political Hinduism is pitted against political Islam as in certain constituencies of Telangana or Kerala – or where another religious ideology is at play, as during Punjab's latest bypoll (won by a religious secessionist), Hindutva is often not even a factor. Our political pundits



have been more cynical than our electorate, which wants change and is chasing the mirage of political idealism. And that is the only reason the BJP is not even in the reckoning in the states where it cannot offer change or a credible alternative. Its Hindutva cannot compete with a vibrant rival. That is the only reason it becomes a marginal player in most southern states. Even where it has gobbled up the Opposition space from the Congress, like in Odisha, the BJP has not been able to shake the people's faith in a performing CM. Even the much-derided dynastic politics is not a deterrent, as is proven in Tamil Nadu, Andhra Pradesh or even Odisha, where Naveen Patnaik's astute administrative mechanism is wrapped around his father Biju Patnaik's legacy. Hindutva works only where the opponents are weak, self-serving and greedy beyond political goals. And, it works against the Congress as it is drifting in search of an identity. It is politically fashionable to hail Rahul Gandhi as the only Opposition leader who has taken on the RSS and Hindutva. But has he? He had to abandon his family's pocket borough and its electoral legacy to seek refuge in a hilly constituency dominated by Muslim and Christian voters. So, if he is identifying himself with Muslim and Christian voters and representing them in Parliament, how is he taking on an organisation that represents Hindus? Identity politics cuts both ways and is proving to be more helpful to larger communal identities than smaller groups. Rahul is only politically and ideologically legitimising religious

identity politics and thereby validating the RSS, the most successful practitioner of this brand of politics, by banking on Muslim and Christian voters of Wayanad.

The elitism and condescension of the Congress leadership, coupled with its one-trick poll pony — identity politics were rejected in Punjab, with even Dalit voters voting out a Dalit CM. The Congress leadership still has no answer for the envy and aspiration of the middle and workingclass voters, who find only elite opportunism in the politics of upper-class liberals, including that of Rahul. The problem with the present-day Congress leadership is not even the first family remaining out of touch with the party's leaders and cadre — the problem is lack of representation of the masses. The Gandhis still have not answered the question of representation. Who do they represent in terms of the identity politics they always practise? The minorities? The Muslims and the Christians have their own parties and do not need the Gandhis. Rahul needs Muslim League and Kerala Congress (a Christian party not to be confused with INC) voters more than the latter needing his endorsement. The Congress ought to be representing larger groups and hence should have a peasant caste or an OBC president — an Ashok Gehlot or a Bhupinder Hooda, someone who is a fulltime politician. Indian democracy badly needs a strong dose of grassroots, representative politics, as against identity politics. Even the Hindi heartland would dump Hindutva if a credible alternative offers hope and change.

EC should frame guidelines on pre-poll promises

Jammu AND kashmir has been without an Assembly since November 2018, when the House was unexpectedly dissolved just months after the state was brought under Governor's rule as the BJP pulled out of the Mehbooba Mufti-led government. Three years after the abrogation of Article 370, elections in the newly created Union Territory are still not on the horizon. The Delimitation Commission report was cited as a precursor to the resumption of the long-stalled political process. The panel completed its twoyear-long exercise to redraw the electoral map this May, notifying six additional constituencies for the Jammu region and one for Kashmir. The criticism by the regional political parties that the changes give an unfair advantage to the BJP notwithstanding, the delay in the announcement of

Assembly polls is inexplicable.

Much has been made of the record tourist footfall and several other gains on the development front since the



revocation of the special status, but the real test lies in restoring the electoral process. The tough stance to contain the separatist sentiment has meant sustained detentions, dismissals from service, attachment of properties and frequent crackdowns. It would be hugely

erroneous, though, to hide behind the iron-hand policy to justify depriving people of their constitutional right to choose representatives, and not letting them have their say.

Incidents related to law and order as well as terrorism have come down since 2019 and more than 690 terrorists have been killed in Jammu and Kashmir during the period, but recruitment and targeted killings remain a cause for concern for the security apparatus. Half of the fresh recruits are said to be uncategorised, posing a new challenge when the youth, who otherwise lead normal lives, indulge in acts of terror when directed to do so, before resuming their routine work. The Election Commission has started work on the revised voter list and while

restoration of statehood is a demand that may not find immediate resonance, holding elections would require no such predicament. August 5 cannot be remembered as a day of disempowerment.

Rebuild agriculture to make it future-ready

With Green Revolution having outlived its

utility, it's time to move to the next
stage. The 75th anniversary of
Independence provides an excellent
opportunity to rethink and redesign the
road map. This will call for moving away
from the economic thought that has
always relied on sacrificing agriculture
for the sake of industry. The focus has
to be on making the village the hub of
hopes & aspirations.

GIVEN the spectacular role Indian farmers have played in pulling the country out of the 'ship-to-mouth' existence and turning it into a food-surplus nation, agriculture has emerged as the brightest star of the Indian economy. Whether we would like to publicly acknowledge it or not, a vibrant agriculture had laid out a strong foundation for economic growth.

As India celebrates 75 years of Independence, it is time to recognise that the pathway to attain a glorious future in the next 25 years passes through agriculture. With the right kind of policy mix and a renewed cycle of public sector investments, aimed more at farmers' welfare and protecting the environment, agriculture alone has the potential to reboot the economy, sustain millions of livelihoods, and in the process emerge as a powerhouse of economic growth. More so, at a time when the Intergovernmental Panel on Climate Change has begun to question the GDP-based growth model, rebuilding sustainable agriculture will hold the key to India's development story. From the time when Jawaharlal Nehru, speaking from the ramparts of the Red Fort on August 15, 1955, had said, "It is very humiliating for any country to import food. So everything else can wait, but

not agriculture," India has come a long way by attaining food self-sufficiency and leaving the painful history of repeated famines and starvations in the past. Subsequently, Nehru's successor, Lal Bahadur Shastri, faced the humiliation that comes along with food imports. Calling the American war in Vietnam as 'an act of aggression' Shastri had annoyed the then US President Lyndon Johnson. Food imports into India under the PL-480 scheme were thereby reduced to a trickle, necessitating the Prime Minister to urge fellow Indians to fast once a week.

During that period, the Paddock brothers' book Famine 1975! had written off India and predicted that millions would starve to death in the years to come. That was the period when India earned the epitaph 'ship-to-mouth' existence when food would come directly from the ship to the hungry mouths. Anyway, what the authors, popularly

referred to as the prophets of doom, had failed to visualise was the potential of India to rebound on the food front, and usher in food self-sufficiency in the next few years. When the then PM Indira Gandhi allowed the import of 18,000 tonnes of miracle dwarf wheat varieties in 1966, the seeds of the Green Revolution were effectively sown. With the scientific research and development infrastructure already laid out by Nehru when he had set up the first agricultural university at Pantnagar, followed by Punjab Agricultural University at Ludhiana, which along with the Indian Agricultural Research Institute, New Delhi, eventually helped adapt the dwarf wheat varieties to the Indian conditions. The seeds were distributed to farmers in 5-kg packs; and the over-enthusiastic Punjab farmers turned the tables, achieving a record harvest in the first year.

The success in wheat was followed in rice, and subsequently production jumped in crops like cotton, sugarcane, and fruits and vegetables. India now produces



close to 315 million tonnes of foodgrains and 325 million tonnes of fruits and vegetables. From standing with a begging bowl, the long strides India had taken to first move to food self-sufficiency and finally emerging as a net agricultural exporter is a saga of valour, scientific acumen and the right kind of public policies. This included the two planks of a 'famine-avoidance' strategy — providing farmers with the Minimum Support Price (MSP) to act as an incentive, and setting up of the Food Corporation of India (FCI) to mop up the huge market arrivals, and distribute the grain surplus in the deficit areas through a network of public distribution outlets.

Prior to the advent of the Green Revolution (a term coined later by William Gaud), Shastri had laid the foundation of a milk revolution when he launched the cooperative movement to increase the production of supply of milk. Called popularly as the White Revolution, it is considered to be the world's most successful rural development programme. The dairy cooperatives have turned India into the world's largest producer of milk,

with production crossing 204 million tonnes. The combination of the White Revolution with the achievements of the Green Revolution transformed the face of India's villages; dairy farming has come to be regarded as the saviour of the farming community reeling under acute distress.

Farmers have been producing a record harvest every year, but year after year, their incomes remain frozen or are on the declineAlthough the latest report of the Situation Assessment Survey for Agricultural Households, 2019 (pertains to a period before the lockdown) points to an average farm income of

Rs 10,286 (including income from non-farm activities) per month, the massive reverse migration that India witnessed after the lockdown was imposed clearly shows that the immediate need is to make agriculture

more profitable and economically viable. At a time when the world is faced with jobless growth, with increased pace of automation taking away jobs at a fast pace, reviving agriculture remains the only option to absorb the large workforce. This will drastically reduce the employment pressure on the cities. With the Green Revolution having outlived its utility, it is time to move to the next stage. The 75th anniversary of Independence provides an excellent opportunity to rethink and redesign the future road map. Eight of top-10 firms add Rs 98,235 cr in m-cap; Infosys, TCS lead gainers

New Delhi: Eight of the 10 most valued firms together added Rs 98,234.82 crore in market valuation last week, with IT majors Infosys and TCS emerging as the biggest gainers amid a positive momentum in equities.

Last week, the BSE benchmark Sensex advanced 817.68 points or 1.42 per cent.From the top-10 pack, HDFC twins were the only laggards.The market valuation of Infosys jumped Rs 28,170.02 crore to reach Rs 6,80,182.93 crore.Tata Consultancy Services (TCS) added Rs 23,582.58 crore, taking its valuation to Rs 12,31,362.26 crore.The market valuation of Reliance Industries Limited climbed Rs 17,048.21 crore to stand at Rs 17,14,256.39 crore and that of ICICI Bank advanced Rs 13,861.32 crore to Rs 5,83,261.75 crore.

The market capitalisation (m-cap) of Life Insurance Corporation of India (LIC) went higher by Rs 6,008.75 crore to Rs 4,34,748.72 crore and that of Bajaj Finance increased Rs 5,709.2 crore to Rs 4,42,157.08 crore.

State Bank of India's valuation went up by Rs 2,186.53 crore to Rs 4,73,584.52 crore and that of Hindustan Unilever Limited (HUL) advanced by Rs 1,668.21 crore to Rs 6,21,220.18 crore.On the other hand, the mcap of HDFC declined by Rs 4,599.68 crore to Rs 4,27,079.97 crore.HDFC Bank's valuation dipped Rs 4,390.3rore to Rs 7,92,860.45 crore.In the ranking of top-10 firms, Reliance Industries retained the title of the most valued domestic company, followed by TCS, HDFC Bank, Infosys, HUL, ICICI Bank, SBI, Bajaj Finance, LIC and HDFC.

FPIs buy shares worth Rs 14,000 cr in a week amid softening dollar index



New Delhi: After turning net buyers last month, foreign investors continued their positive stance on Indian equities and invested over Rs 14,000 crore in the first week of August amid softening of the dollar index.

This was way higher than the net investment of nearly Rs 5,000 crore by Foreign Portfolio Investors (FPIs) in entire July, data with depositories showed.

FPIs had turned buyers in July after nine straight months of heavy net outflows, which started from October last year. Between October 2021 and June 2022, they sold a massive Rs 2.46 lakh crore in the Indian equity markets.

Hitesh Jain, Lead Analyst - Institutional Equities, Yes Securities, said FPI flows are expected to remain positive during August as the worst for the rupee seems to be over and crude oil price seems to be confined in a range.

"Also, earnings story still remains strong where sturdy revenue growth is offsetting contraction in profit margins," he added. According to data with depositories, FPIs infused a net amount of Rs 14,175 crore in Indian equities in the first week of August. The change in FPI strategy has imparted strength to the recent market rally.

"The decline in the dollar index from the high of above 109 last month to below 106 now is the principal reason for FPI inflows. This trend may continue," said V K Vijayakumar, Chief Investment Strategist at Geojit Financial Services.

Also, comments from Fed Chair Jerome Powell that currently the US is not in a recession has helped improve sentiment and risk appetite globally, said Himanshu Srivastava, Associate Director - Manager Research, Morningstar India. The recent correction in the Indian equity markets have also provided a good buying opportunity, and FPIs have been taking advantage of the same by hand-picking high quality companies, he added.

FPIs have turned buyers in sectors like capital goods, FMCG, construction and power. In addition, FPIs poured a net amount of Rs 230 crore in the debt market during the month under review.

According to Srivastava, the flows have been largely driven by short-term trends.

Further, the China and Taiwan equation is another watching point and rising tensions between the two could disturb and enhance geopolitical risks in the region. This could adversely impact the flows, he said.

India's auto industry expects high sales on back of new launches, improved production | Details

The festive season, which usually witnesses a spike in automobile sales, begins this year on August 11 with Rakshabandhan stretching up to Diwali on October 25.

New Delhi. The auto industry expects car sales to be on the fast lane this festive season on the back of new launches and improved production but is cautiously optimistic on the road ahead once the festivities peter out.

We expect the festive season this year to be the best in terms of passenger vehicle sales on the back of new launches and improved production activity. The industry has been rolling out over 3 lakh units on an average in the past 4-5 months which is helping in retails," automobile dealer's body President Vinkesh Gulati told PTI in an interaction. He listed erratic monsoon in some parts of the country, inflationary pressures and the looming threat of a China-Taiwan war as some of the challenges to watch out for in the days ahead.FADA represents over 15,000 automobile dealers across the country. Kia India Vice President and Head of Sales & Marketing Hardeep Singh Brar said that supply chain issues are now showing signs of easing off, and market sentiments remain bullish. "We are optimistic that a good festive season is ahead of us in terms of sales," he added.

Tata Motors President Passenger Vehicle and Electric Vehicles Shailesh Chandra



said the company does not see a concern regarding the customer demand until the end of the festive season. In an analyst call, he said that the automaker expects the vehicle supply to improve with better semiconductor availability in the second quarter. "Going forward the challenges we see is that the high inflation and interest

rate may start impacting the auto demand while there's no stress as far as the second quarter is concerned," he stated. As far as Tata Motors is concerned, the company remains focused on demand generation activities, Chandra noted. Maruti Suzuki India Senior Executive Director (Marketing and Sales) Shashank

Srivastava said the demand seems to be steady at the moment. "We have to watch out for the retails, currently we are digging conclusions based on wholesales and on the pending bookings...retail sales have been less than wholesales for the last few months...we also need to see how the economy performs overall and how the inflation and interest rates move," he noted.

Customer sentiment can witness change on account of these factors, he said. Elaborating on the overall performance of the industry, he stated that in the April-July period this fiscal the passenger vehicle industry has witnessed a growth of 33 per cent over the same period last financial year. The PV sector has sold 12.53 lakh units this year as compared with 9.41 lakh units last year, Srivastava said. He noted that at the beginning of April the industry stock was estimated to be around 1.20 units which has now gone up to about 2.12 lakh units because the wholesale has been exceeding the retails. "Therefore we need to be careful going forward as to how it reflects in the future market scenario. At the moment, because of the high pending payments, whatever is being produced is being pushed into the market," he said.

Alibaba lays off nearly 10K employees amid poor sales

Beijing Chinese tech conglomerate Alibaba has bid goodbye to nearly 10,000 employees in an effort to cut expenses amid sluggish sales and a slowing economy in the country, the media reported on Saturday. According to South China Morning Post, more than 9,241 employees left Hangzhoubased Alibaba during the June quarter, as the company trimmed its overall headcount to 245,700. "That put the total decrease in employee numbers for Alibaba, owner of the South China Morning Post, to 13,616 over the six months to June, marking the firm's first drop in payroll size since March 2016," the report noted.

Alibaba reported a 50 per cent drop in net income to 22.74 billion yuan (\$3.4 billion) in the June quarter, down from 45.14 billion yuan in the same period last year."The reduced payroll reflects Alibaba's renewed efforts to cut expenses and drive up efficiency, as it faces continued regulatory pressure, sluggish consumption and a slowing economy in China, the world's biggest ecommerce market," the report noted.

Alibaba Chairman and CEO Daniel Zhang Yong said the company will add nearly 6,000 fresh university graduates to its headcount this year.

Last month, reports surfaced that billionaire Jack
Ma is planning to give up his control of Ant Group



amid pressure from the government regulators. According to a report in Wall Street Journal, the move is aimed at part of the fintech giant's effort to move away from affiliate Alibaba Group Holding that is under immense scrutiny from the government. Since last year, Chinese regulatory authorities have been cracking down harder on domestic tech giants like Alibaba and Ant Group to end their dominance in the internet sector. According to the report, Ma could relinquish his control by transferring some of his voting power to other Ant officials, including

Chief Executive Eric Jing.

7th Pay Commission: Govt may hike DA in second half of 2022; Know when it will be implemented

New Delhi: The Reserve Bank of India maintained its inflation prediction for the current fiscal year 2022-23 at 6.7%. According to the monetary policy statement, "the inflation projection is maintained at 6.7 percent in 2022-23, with Q2 at 7.1%, Q3 at 6.4%, and Q4 at 5.8 percent, with risks evenly balanced." CPI inflation is expected to be 5.0 percent in Q1:2023-24." With inflation rates remaining unchanged, central government employees should anticipate a DA increase in the following months. According to reports, the government may raise DA and DR by up to 4%. Retail inflation is used to modify DA and DR.

The AICPI was 125.1 in January and February, and 125 in March, before rising to 126 in March. The April AICPI jumped to 127.7 due to rising inflation. AICPI increased significantly to 129 in May. If the AICPI maintains at that level, a 4% increase in DA is probable. In April, CPI-based inflation reached an eight-year high of 7.79%. However, it fell to 7.01 percent in JuneCurrently, government employees receive a 34% DA on their basic wage. If the 4% DA increase is enacted, they will

receive a 38% dearness allowance on top of their base wage. Dearness allowance (DA) is paid to government employees, whilst dearness relief (DR) is paid to retirees. In March of this year, the government updated the DA, which then increased by 3% to 34% of an employee's basic wage. This was done in response to rising costs, and the central government increased DA by 3% to compensate for the inflation rate. The April AICPI has fueled speculation that the government may adopt a 4% DA increase in 2015. Read More: SBI net profit dips 7% to Rs 6,068 crore in Q1According to the department of expenditure's announcement, if an employee's basic pay is Rs 18,000, he or she will receive a Dearness Allowance of Rs 6,120 following the April raise. Previously, the employee received Rs 5,580 in DA at a rate of 31%. This means that the last DA hike resulted in a Rs 540 increase. If the DA is increased by another 5%, the DA will be Rs 7,020 if the employee receives 39% DA on a basic salary of Rs 18,000. This means that if the 5% DA increase is applied, the salary will rise by Rs 900.

New Delhi In a rematch of the T20 World Cup 2020 final, India and Australia will clash for the gold medal at the 2022 Commonwealth Games on Sunday (August 7). While the Down Under side is considered favourite in the tournament, the Women in Blue have all the luck on their side to cause an upset.

Although there is a visible gap between Australia and the rest of the world in women's cricket, India came close enough to stun Meg Lanning's team in the opening match at the Commonwealth Games. It was pacer Renuka Singh who rattled the top order and reduced Australia to 49/5 before Ash Gardner stood tall and reaffirmed the depth in the Australian lineup.

India bounced back in the group stage, while Australia maintained their perfect run to reach the semi-finals, where India edged past the hosts England and Australia defeated New Zealand. India met England in a repeat of the 2018 and 2020 T20 World Cup semifinals, but their approach this time around was aggressive as Smriti Mandhana gave India a dream start. India couldn't build on the perfect start in the middle over, but Jemimah Rodrigues lifted the side, which turned out to be the difference as England fell short by four runs. Come the final, India will need to go big in order to keep Australia on the backfoot. Australia, on the other hand, are looking to complete a treble on the golden Sunday, having won the 2020 T20 World Cup and the 2022 ODI World Cup. The Australian bowlers, led by Megan Schutt, restricted New Zealand to a moderate total. Barring Sophie Devine and Amelia Kerr, no Kiwi player could manage to tackle the mighty Australians. Although Australia opener Alyssa Healy hasn't fired yet, she cannot be underestimated. She is a big game player and was the one who setup the 2020 final for Australia against India.

4th T20I: Axar Patel's allround heroics help India hammer West Indies, take 3-1 unbeatable series lead

New Delhi Axar Patel hogged the limelight with a starring all-round performance as India hammered West Indies by 119 runs in the fourth T20I to take a 3-1 unbeatable lead in the five-match series in Lauderhill on Saturday. After being invited to bat, India rode on Rishabh Pant and skipper Rohit Sharma's useful enough contributions to post a competitive total of 191 for 5 in the fourth T20I against West Indies on Saturday. The visitors then returned to dismiss West Indies for 132 in 19.1 overs with Arshdeep Singh picking up a career-best three-wicket haul and Avesh Khan, Axar, and Ravi Bishnoi returning with twowicket hauls.

West Indies vs India, 4th T20I: Highlights

Rohit (33) and Pant (44) were the main contributors, while Axar Patel struck some meaty blows towards the end to finish unbeaten on 20 off 8 balls. West Indies leftarm pacer Obed McCov was smoked for 66 runs off his 4 overs only a week after taking a career-best six-wicket haul in the second ODI. It was the most expensive spell by a West Indies bowler in T20Is.

McCoy went for three sixes and 25 runs in an over. In those three, Rohit had a couple -- a pullover deep mid-wicket and a flat one over long-off. Rohit then slog-swept six off Akeal Hosein (1/28 in 4 overs), but the very next delivery, which was a tad slower and the length slightly shorter, brought about his downfall.But Rohit's 33 in a stand of 53 in less than five overs set the tone and gave other batters time and confidence to go after the bowling. The cushion of the strike rate gave Pant and Deepak Hooda (21 off 19 balls) close to six overs to produce a 47-run stand, which was the launch pad for the final flourish from Axar.

Birmingham. Paralympic Silver medalist Bhavinaben Hasmukhbhai Patel became the first Para TT player to win a gold medal at the Commonwealth Games after she defeated Nigeria's Ifechukwude Ikpeoyi by 12-10, 11-2, 11-9 in the women's single class 3-5 final in Birmingham on Saturday.

Bhavinaben had a good start in the final against World No. 41 Ifechukwude Ikpeoyi of Nigeria. She took the opening game 12-10 in a close contest. She held her nerves to take the opening game. Bhavinaben was in tears after she realized the enormity of the achievement. She was trailing 2-9 in the third game but Bhavinaben produced a superb effort to win 8 straight points and the Gold medal. She became only the second paraathlete to win Gold after weightlifter Sudhir.

Bhavina reached the world No. 2 ranking by winning the silver medal in the individual category at the 2011 PTT Thailand Open.

Besides, she also won a silver medal in the women's singles class 4 at the Asian Para Table Tennis Championships in Beijing in



Vinesh Phogat nearly quit wrestling, unable to cope with the mental agony of getting knocked out in the opening round of her Tokyo Olympics campaign after having headed to the Games as one of the clear favourites. Vinesh suffered a heartbreaking injury in the quarter-final bout of her maiden Olympic appearance in Rio but she was not able to make up for it in her second chance at the Games in Tokyo.
